- d. <u>Construction Observation Report for November 2020, Short Elliott Hendrickson, Wastewater Construction Project</u> The City Council was given the Construction Observation report for November 2020 from Short Elliott Hendrickson, the construction management company, on the Wastewater Improvement/Construction project. No action taken.

- a. Councilmember Gosiak reviewed a message received regarding the City maintenance of the bike trails and snow removal of said trails near Charles Lindbergh State Park and Maple Island Park. - b. Councilmember Lundberg reviewed that the southbound red signal light on Eighteenth Street East at Trunk Highway 27 is out.
